



ROSGLAVVODA 2024 REGISTRATION AND SHIPMENT

1. Select the category

Selecting the correct category is an important step. The detailed description of the categories can be downloaded from www.rosglavpivo.ru. Neither ROSGLAVVODA employees nor associations- contest organizers or their partners may assist with the category selection.

Every commercially-operated plant, which is properly registered according to respective national law, including micro- and mini-plants is entitled to participate. The participating Russian company must itself manufacture drinks registered for the competition.

2. Registration and submission of documents

- Registration shall be carried out online at www.rosglavpivo.ru.
- The easiest way to register is online.
- A company can register by fax or e-mail using the registration form, in this case the confirmation that the registration fee has been paid must be attached to it.
- Participation implies consent with the conditions of the competition, refer to www.rosglavpivo.ru.
- A plant can register as many drinks as wishes in different categories.
- The drinks submitted must be exactly the same as those able to be purchased by end customers in their composition, packing and labelling.

3. The registration fee

RUSSIA (zero rated for VAT)

up to 30th September per beer **12.000 RUB**
from 1st October per beer **15.000 RUB**

INTERNATIONAL (zero rated for VAT) 10.000 RUB

EARLY-BOOKER DISCOUNT:

up to 30th September

Registration closing date: established by the organizer

4. Registration confirmation

We will send you a confirmation form after you have registered and sent the documents. Please check and complete this form, sign it and return it by fax or scan it and send it by e-mail.

5. Packing and sending

Each bottle must be identified with an adhesive label containing the following data:

- Entry a number of the drink, assigned by the organizer (see p.4)
- Number of the category (see category list of “ROSGLAVVODA” competition)

Each bottle must bear the label that is used for its commercial sale. The bottles must be delivered packaged. Each sender is responsible for packing and sending: the organizers of the ROSGLAVVODA and its partners shall accept liability.

The following quantities must be sent in for the first tasting:

Bottle content:	Number of bottles:
0,5 л	8
at least 0,5 l	12

To avoid breakages, the following measures are recommended:

- Wrap each bottle individually in blister pack
- Place each bottle upright in a suitable packing box
- Fill the free space in a box with a suitable packing material
- Write on each box “Fragile” and “This side up”

We recommend to send drinks in a crate covered to the top with a fixed wooden plate.

Each sender is responsible for complying with the legal shipping regulations.

6. Submission of drinks

Send the drinks within the time period determined by organizers of the competition to the following address:
