



ROSGLAVPIVO® 2022 REGISTRATION AND SHIPMENT

1. Select the beer category

Selecting the correct beer category is an important step. The detailed description of the categories can be downloaded from www.rosglavpivo.com.

Neither ROSGLAVPIVO® employees nor associations-contest organizers or their partners may assist with the category selection.

Every commercially-operated brewery, which is properly registered according to respective national law, including micro- and mini-plants ("craft breweries"), is entitled to participate. The participating Russian brewery must itself manufacture the beer registered for the competition and market it verifiably under its own name. Exception - categories: "Innovative Beer", "Experimental Beer" and "Home-brew Beer".

2. Registration and submission of documents

- Registration and payment shall be carried out online at www.rosglavpivo.com.
- The easiest way to register is online.
- A brewery can register by fax or e-mail using the registration form, in this case the confirmation that the registration fee has been paid must be attached to it.
- Participation implies consent with the conditions of the competition, refer to www.rosglavpivo.com.
- Only beer (according to the Federal Law № 218 from 18.07.2011) can be registered. Exception - categories: "Innovative Beer", "Experimental Beer" and "Home-brew Beer".
- A brewery can register as many beers as wishes in different categories.
- The alcohol content of the beer must be declared with the registration.
- The beers submitted must be exactly the same as those able to be purchased by end customers in their composition, packing and labelling. Exception - categories: "Innovative Beer", "Experimental Beer" and "Home-brew Beer".

3. The registration fee

RUSSIA (zero rated for VAT)

INTERNATIONAL (zero rated for VAT)

up to 31st December per beer **10.000 RUB**
from 1st January per beer **12.000 RUB**

SPECIAL DISCOUNT

(from the 3rd registered beer):

RUSSIA (zero rated for VAT) 8.000 RUB
INTERNATIONAL (zero rated for VAT) 8.000 RUB

EARLY-BOOKER DISCOUNT:

up to 31ST December

Registration closing date: established by the organizer

4. Registration confirmation

We will send you a confirmation form after you have registered and sent in the documents. Please check and complete this form, sign it and return it by fax or scan it and send it by e-Mail.

5. Packing and sending the beers

Each bottle must be identified with an adhesive label containing the following data:

- Entry number of the beer (see confirmation fax)
- Number of the beer category (see category list of «ROSGLAVPIVO®» competition)

Each bottle must bear the beer label that is used for its commercial sale. Exception - categories: "Innovative Beer", "Experimental Beer" and "Home-brew Beer". The bottles must be delivered packaged. Each sender is responsible for packing and sending: the organisers of the ROSGLAVPIVO® and its partners shall accept liability.

The following quantities must be sent in for the first tasting:

Bottle content	Number of bottles
at least 0,5 l	6
less than 0,5 l	10

To avoid breakages, the following measures are recommended:

- Wrap each bottle individually in blister pack
- Place each bottle upright in a suitable packing box
- Fill the free space in a box with a suitable packing material
- Write on each box «Fragile» and «This side up»

We recommend to send beers in a beer crate covered to the top with a fixed wooden plate..

Each sender is responsible for complying with the legal shipping regulations.

6. Submission of beers

Send the beers within the time period determined by organizers of the competition to the following address:
